

**Carbon-La Costa Beach Acquisition of Property**  
**Date of Publication: Thursday, October 30**

At its December 11, 2003 regular meeting, the California State Coastal Conservancy will consider for possible approval the acquisition of a vacant parcel, Los Angeles Assessor's Parcel No. 4451-004-031, located south of Pacific Coast Highway at the intersection of Carbon and La Costa Beaches in Malibu, California for the purpose of scenic visual access to it and an adjacent parcel, Los Angeles Assessor's Parcel No. 4451-003-033, previously dedicated to the Coastal Conservancy for the purpose of vertical coastal access, and as the Lead Agency under the California Environmental Quality Act, the possible adoption of a mitigated Negative Declaration for this project. The draft Negative Declaration is available for public review and comment from October 30, 2003 through November 28, 2003. All comments must be received by 5:00 p.m. on November 28, 2003 at the California State Coastal Conservancy office, 1330 Broadway, Ste. 1100, Oakland, CA 94612.
