We have not yet developed a plan for the property, but our intention is to make some site improvements to provide for some level of public use.

Since you are one of the adjacent neighbors, we want to include you in the planning process early on. We want to develop site improvements that will meet our needs both for providing public access to the beach and respecting private property. We want to design something that can be well managed and enjoyed by neighbors and visitors alike. We will need your help and advice to do that. Accordingly, we will be contacting you to set up a time to meet, face-to-face, to discuss our initial thoughts and get your feedback on the access issues as they affect you and your property. We are currently in the process of filling some staff positions here at the Coastal Conservancy and hope to be adequately staffed by early spring to initiate the planning process for this property.

We do not want to create an eyesore on the property while we are developing the plan for site improvements. We hope that this interim minimal management by MRCA will be sufficient.
